This program helps families and individuals with Housing Choice Vouchers (previously Section 8 Vouchers) find new housing choices in areas of opportunity. By working closely with landlords and by empowering you with knowledge and tools to become a good tenant, we can help ensure you find a home in a neighborhood that is right for you and your family.

HOME can help:

Assign a counselor to help you during your housing search.

Work closely with landlords to accept your Housing Choice Voucher.

Provide guidance through the leasing process.

Provide follow up and supportive services.

Fair Housing Laws Protects You

Source of income, or source of funds, became a protected class in the Virginia Fair Housing Law on July 1, 2020.

You are protected if you receive:

- Housing Choice Voucher (Section 8)
- Social Security Disability Income (SSDI)
- Supplemental Security Income (SSI)
- U.S. Department of Housing and Urban Development-VA Supportive Housing (HUD-VASH)
- Emergency rental assistance from nonprofits
- And others

Discrimination may look like:

- A Landlord charges more or requires an extra deposit for those with a Voucher.
- Rental listings that say “no section 8.”
- A landlord suggesting a tenant does not deserve their Voucher.
- Refusing to rent to an otherwise qualified tenant because of stereotypes about people who receive financial assistance.
